IV. The Board of Adjustment may Discuss and Take Action on the Following Agenda items:

Case #20-001: Applicant Prince Signs (on behalf of McLaw Ventures LLC), is requesting a 10-foot variance from the maximum allowed height of 65 feet allowed a commercial pole sign along a road with a speed limit of 55 mph. The maximum height for a sign in this location is 60 feet when located fifteen feet from curb line, with an additional foot of height allowed for every additional 10 feet from curbside. Variance is required in order to build a new

75-foot tall commercial pole sign to replace an existing sign located at 11619 Interstate 20, being Sec. 1, B3, H&TC Survey, Abstract 260, Eastland, Texas.

Gena Camacho introduced the item and asked for comment from Staff and Applicant.

Tony Stubblefield, Planning and Zoning Director, briefed the Board regarding the variance request submitted by Prince Signs on behalf of Sam Lawson, Mclaw Ventures.

Mr. Stubblefield stated that he sent letters to 6 property owners that were within 200 feet of the property line asking for opposition or agreement with the request of the project. One response was received and it was in agreement with the request.

Mr. Stubblefield presented a slide show of photos detailing the placement of the current sign and gave reasons for the variance request.

Discussion among the board members, Mr. Stubblefield and Sam Lawson resulted in a great conversation regarding the new building and what the Travel Center will bring to Eastland.

Mr. Stubblefield stated that the City has no objection to the variance if the board is in agreement.
