## VII. City Manager's Briefing

City Manager J.J. Oznick briefly covered the report that the commissioners have in their packet.

### **GLO-CDBG-MIT Project Planning**

Mr. Oznick stated we are waiting the results of the H&H study that Texas Government Land Office (GLO) is conducting and should be complete in early 2023.

#### **WWTP Improvements**

The Texas Hwy 6 South Sanitary Sewer Improvements Project is in progress and should be completed in a couple of months.

#### **TXDOT Exit 343 Ramp and Signal Light Projects**

Texas Department of Transportation will begin surveying soon and hope to have the new traffic lights installed at the intersection of E. Main and the Service Roads between October and December.

## VIII. Code Enforcement Report

City Manager J. J. Oznick reported the Code Compliance Report for January 2022. There were 19 open cases at the beginning of the month, 21 new cases were opened and 30 cases were closed which ended the month with 10 cases open. 1 citation was issued and one Case was reported for back taxes. 2 annual notices were sent with fines assessed at \$437.

### IX. Police Report

Chief David Hullum stated there were 233 calls for service in January. 33 cases were filed with the District Attorney. There were 44 offense reports generated. He noted 12 arrests with 16 charges. A total of 661 traffic stops were initiated. This resulted in 529 warning citations and 132 citations issued. He also stated that 206 "business checks" were conducted. Chief Hullum also stated that a Theft of \$16,000 worth of Jewelry from Wal-Mart was solved.

## X. Fire Chief Report

Fire Chief Joe Williamson gave the following activity report for the month of January for the Volunteer and Paid Firefighters. Total call volume: 75 which was an average of 2.43 calls per day. 58 of these were in the City Limits and 13 of them were in the county and they responded to 4 calls for mutual aid to other county fire departments. There were 12 incidents between 10 p.m. and 7 a.m. There were 5 structure fires, 7 grass fire and 0 vehicle fires. They responded to 32 Medical calls, 8 Motor Vehicle accidents and 7 Public Service assists and 16 false alarms/investigations. They installed 1 Smoke Detector.
