# VI. The Board of City Commissioners May Discuss and Take Action on the Following Agenda Items:

 Discussion and Consideration to approve reappointment of Mark Pipkin and Carolyn White for another three-year term on the Eastland Economic Development Board.

City Manager J. J. Oznick stated that the terms for Mark Pipkin and Carolyn White, who serve on the Eastland Economic Development Board, expired on September 30, 2023. They have both agreed to serve another term.

4. Discussion and Consideration concerning award of a construction contract for the GLO CDBG-MIT Grant #22-082-004-D199 – City of Eastland Phase 1 Dam and Creek Channel Improvements Project.

City Manager J.J. Oznick stated that we received several bids for this project. The bids were opened and examined on November 30, 2023 by eHT Engineer Jonathan Baum. Upon checking all references and data submitted, it is recommended that the Project be awarded to Mann Robinson & Sons, Inc for \$450,242.50.

Commissioner Richard Rossander made a motion, seconded by Commissioner Shirley Stuart, to award the construction contract Project for the GLO CDBG-MIT Grant #22-082-004-D199 – City of Eastland Phase 1 Dam and Creek Channel Improvements Project, to Mann Robinson & Sons, Inc for \$450,242.50.

### VII. City Manager Report

### **GLO-CDBG-MIT Project Planning**

Home buy-outs are still ongoing with details being finalized. There was some staff turnover in Austin that has brought about some delays.

### **TXDOT Exit 343 Ramp and Signal Light Projects**

Construction has started. Great progress is being made on constructing a turn lane from the north access road all the way to the Old Bankhead Highway.

## VIII. Code Compliance Report

Planning and Zoning Director Tony Stubblefield reported the Code Compliance Report for November 2023. There were 75 open cases at the beginning of the month, 12 new cases were opened and 68 cases were closed, which ended the month with 19 cases open. 3 Citations were issued: 1 for Dangerous Building; 2 for Unlawful property nuisance.

## IX. Police Chief Report

Chief Tim Pitts stated there were 324 calls for service in November. 9 cases were filed with the District Attorney. There were 37 offense reports generated. He noted 14 arrests. A total of 390 traffic stops were initiated. This resulted in 236 warning citations and 154 citations issued. He also stated that 625 "business checks" were conducted. Our Animal Control Officer continues to be very active with 95 business calls. 18 animals were impounded and 6 were adopted and 2 were quarantined.

Chief Pitts also reported that during the month of November they had DWI-SFST training as well as training on the FN-303: Less lethal Training.

### X. Fire Chief Report

Fire Chief Joe Williamson was not available and will give the activity report for the month of November and December 2023 at our next meeting in January.

## XI. Adjournment

Commissioner Richard Rossander made a motion, seconded by Commissioner James Doyle, to adjourn at 7:30 p.m. Motion passed unanimously.
